WORLD HONEY BEE DAY

World Honey Bee Day on the third Saturday in August brings a buzzing celebration for beekeepers, honey lovers, and all blooming things.

The day recognizes both the honey bee and the beekeepers who tend the hives. It also encourages everyone to enjoy and buy locally grown honey.

Another important part of the day includes learning about honey bees and providing them with a supportive environment. When we plant wildflowers, orchards, and other flowering plants, we support pollinators such as honey bees. They depend on the nectar of a variety of plants for their survival. Conversely, we depend on honeybees for our survival, too! Without their pollinating abilities, many nutritious plants wouldn't reproduce.

Besides, their delicious honey is an added bonus. We enjoy it in our baking, teas, and confections.

Honey bees do sting, but only if they perceive a threat – damage to their hive or being swatted at. Since they seek sweet nectar, sugary drinks and sweets will attract honey bees when flowers are not blooming yet. So, keep your beverages covered. If a honey bee comes close, either hold still or move slowly away. The honey bee will fly along to the next sweet thing as long as it doesn't feel threatened.

Grilled Honey Garlic Wings



INGREDIENTS

- 2 1/2 Pound chicken wings
- As Needed Traeger Pork & Poultry Rub
- 4 Tablespoon butter
- 3 Clove garlic, minced
- 1/4 Cup honey
- 1/2 Cup hot sauce
- 1 1/2 Cup blue cheese or ranch dressing

STEPS

Start by segmenting the wings into three pieces, cutting through the joints. Discard the wing tips or save them to make a stock.

Lay out the remaining pieces on a rimmed baking sheet lined with nonstick foil or parchment paper. Season well with Traeger Pork & Poultry Rub.

When ready to cook, set Traeger temperature to 350°F and preheat, lid closed for 15 minutes.

Place the baking sheet with wings directly on the grill grate and cook for 45 to 50 minutes or until they are no longer pink at the bone.

To make the sauce: Melt butter in a small saucepan. Add the garlic and sauté for 2 to 3 minutes. Add in the honey and hot sauce and cook for a few minutes until completely combined. Keep sauce warm while the wings are cooking.

FROM THE VILLAGE – Some questions have come to light following the recent wind storm that caused havoc with limbs and trees in Ansley. First it is important to know that many trees have been planted in Village right-of-way over the years; those trees were not planted by the Village but by current or former property owners. The Village does not usually stop residents from planting trees in street right-of-way but we do ask that you consider how tall and wide the tree will be as it grows and if it will interfere with power lines or cause traffic safety concerns. Also, the tree will be your responsibility and that of future property owners. In other words, the tree does not suddenly belong to the Village when there is a problem. The Village does trim limbs where they interfere with power lines or the overhang causes problems with Village equipment on the streets. The Village crew also helped in many circumstances following the recent storm with removing large branches for people who didn't have the needed equipment. The Village **does not have** equipment capable of removing large trees.

On a similar note, **after August 31, 2020, the Village will NO LONGER HAVE THE COMPOST SITE.** The property owner has expressed he will be ending the annual lease agreement effective that date. While the Village Board recognizes this will cause a hardship for residents, no alternative solution has been determined. Many factors weigh into the responsibility of providing a site; cost, location, ability to monitor, reliance on citizens using the site properly and only dumping compost materials, natural wood or untreated lumber. Our permit specifically states it is issued for an **“open fire for the purpose of the destruction of untreated wood and trees. Any materials other than those specified may cause revocation of the permit or civil penalties of up to \$10,000 per day.”** Unfortunately, too often at the current site unacceptable materials have been dumped; tires, furniture, metal, treated lumber, and the list goes on. While the Village does not burn those materials, we are still subject to the permit revocation and civil penalties if the materials are discovered at the site during a spot inspection.

Just a REMINDER that tree limbs, grass, vegetative waste, dog waste and cat litter CANNOT be put in your tote cart or a dumpster. These materials are not allowed in the landfill, so your trash will not be picked up if these things are present. If you have any questions, concerns or suggestions for solutions please do not hesitate to contact village board members.



Ansley, Custer County, Nebraska

Thursday, September 12, 1912

ANSLEY AND ITS ENVIRONMENTS

SOME INTERESTING FACTS AND FIGURES COMPILED BY THE ANSLEY COMERCIAL CLUB

Custer County from its size has become generally known as "The State of Custer." Its dimensions are forty-eight by fifty-four miles, and contains 1,685,880 acres of rich, productive lands, which would make 10,413 farms of 160 acres each or 20,824 farms of eighty acres each. Custer county justly claims to possess one of the richest and most productive soils in the great Garden State. The rich, dark loam, with deep clay subsoil, renders fertilization a thing practically unheard of. At least three-fourths of the entire county is smooth tillable land, and the balance the finest of pastureland. The hilly lands are finely adapted to our great livestock interests and are scattered by nature most admirably for mixed farming in any part of our county.

Custer county has the natural resources to support in plenty and comfort a population of 100,000 souls. Our population in 1880 was 2,211. The census of 1910 shows that Custer county has more than 27,000 population. Our present population consists of more than nine-tenths Americans, people from the Eastern States; the balance are Germans, Swedes and Bohemians located in different communities in different parts of the county. No county in New England can boast of a more intelligent citizenship, and there is room for tens of thousands more of just such people.

Railroads in Custer County

The Chicago, Burlington & Quincy's great overland railroad system furnishes our county with ample railroad facilities. The main line of this great road traverses our county from the southeast to the southwest corner. They also have a branch entering the northeast corner of the county and running as far as Sargent. Under the able management of energetic, courteous and efficient officers, they have done more to open up and develop the resources of Nebraska than any other system.

The Crops

Custer County is located in the great corn belt of the United States, and "Corn is King" within her borders. All cereals are produced in luxuriant abundance. Vegetables raised in Custer County are world-beaters in quantity and quality. To prove our claim to being a garden spot in the great West, we will state that Custer County holds the Gold Medal presented her by the Nebraska State Fair Association for having three years in succession taken the first prize for agricultural exhibits.

Custer County is not alone a purely farming country. Their livestock interests are very large and increasing rapidly. It is a center for thoroughbred horses, cattle and swine. Some of the finest blooded stock of these classes that can be found West of the Mississippi River, is owned in this county, and the profits in this line are large. Mixed farming and stock raising are finely adapted to cattle raising and every foot of the land in the county can be thus utilized for one purpose or the other.

The Town of Ansley

What we have said regarding Custer County especially applies to that portion of the county lying in the vicinity of Ansley.

Ansley is a thriving little village of more than one thousand souls in the bosom of the fertile and picturesque valley of the Muddy.

Social Advantage

Ansley can boast of having an accredited high school from which her graduates can enter immediately into the State University. There are five churches, all well supported and attended. Our school and church advantages speak more than words for the character of our population. Its citizenship enjoys the luxuries of a water plant and an up to date electric lighting plant, both of which are owned by the municipality. Lake Ansley is a body of water which is created by the damming of the Muddy for the purpose of furnishing waterpower for the electric light plant and pumping station, and affords ample opportunity for all kind of aquatic sports, especially as regards to fishing, boating, bathing and skating. Any visitors to Custer county who fail to avail themselves of the pleasures above mentioned, have failed in their effort to see the best to be found anywhere in the great state of Nebraska.

Business Interests

Ansley boasts of having two large banking institutions, one of which enjoys the distinction of have more money on deposit than any other bank in Custer County.

It will be easy to understand why a bank located in Ansley should have more money on deposit than any other in the county, when you read the following table of exports and imports. From the first of July 1911 to July first of 1912 there were 43 cars of grain, 182 cars of cattle, 221 cars of hogs, 14 cars of horses and 36 cars of sheep shipped out of Ansley; while in the same time there was 2, 538,602 lbs. of merchandise received, 61 cars of lumber, 84 cars of coal, 14 cars of farm implements, 113 cars of miscellaneous goods, and 19 cars of cement and plaster.

The climate of this vicinity is extremely invigorating but not cold in the winter season and the summer nights are cool enough to induce sound sleep, yet the days are sufficiently warm to produce all kinds of temperate zone fruits, vegetables and grain.

The Ansley Commercial Club extends a most cordial welcome to all who desire to investigate the unusual home making opportunities of this garden spot of the globe.

VILLAGE OF ANSLEY**Proceedings****July 6, 2020 – 6:30 p.m.****Municipal Auditorium**

A regular meeting of the Chairperson and Board of Trustees of the Village of Ansley, Nebraska, was held in the Municipal Auditorium on July 6, 2020, at 6:30 p.m. Present were Mills, Smith and Hogg. Absent were Fecht and Henry. Notice of this meeting was by posting as required by law (including on the Village website) and the agenda was communicated in advance. All proceedings hereafter shown were taken while the convened meeting was open to the public. The meeting was called to order at 6:30 p.m., compliance with the open meeting act was verified, and the Pledge of Allegiance was recited by all.

Trustee Smith moved to waive reading and approve the June minutes as presented. Hogg seconded; 3 AYES, 0 NAYS, ABSENT: Fecht and Henry. Motion carried. Bids on the asphalt project were opened, read and tabulated. Trustee Hogg moved to accept the bid on the asphalt overlay project from Gary Smith Construction Company at \$88.96 per ton for both Schedules A and B for a total project cost of \$61,382.40. Trustee Smith seconded; 3 AYES, 0 NAYS, ABSENT: Fecht and Henry. Motion carried.
