

An ordinance of the Village of Ansley, Nebraska to renew the franchise to Newcabe of Ravenna, a Nebraska corporation, for a period of ten years from June 8, 1998 to June 8, 2008, for construction, operation and maintenance within the corporate limits of the Village of Ansley, Nebraska of a community antenna television service, on the terms and conditions provided for in Ordinance 275 (Sections 10-501 to 10-514 of the Municipal Code of the Village of Ansley, Nebraska, 1981, as amended) with amendments, terms and conditions provided for herein; to provide the penalty for violation of the terms of the franchise; to repeal all ordinances or provisions thereof in conflict with this ordinance; and to provide the time when this ordinance shall be in full force and take effect.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF ANSLEY, NEBRASKA THAT:

Section 1. The franchise heretofore granted to Newcabe of Ravenna, a Nebraska corporation, in Ordinance 275 of the Village of Ansley, Nebraska (Sections 10-501 to 10-514 of the Municipal Code of the Village of Ansley, Nebraska, 1981, as amended) for construction, operation and maintenance within the corporate limits of the Village of Ansley, Nebraska of a community antenna television service shall be and the same hereby is renewed for a ten year period, June 8, 1998 to June 8, 2008 on the same terms and conditions as the franchise in Ordinance 275 of the Village of Ansley, Nebraska (Sections 10-501 to 10-514 of the Municipal Code of the Village of Ansley, Nebraska, 1981, as amended), except as repealed or amended herein.

Section 2. The Chairman and Board of Trustees shall have power to require Newcabe of Ravenna to offer services, subject to reasonable rules and regulations, to any person applying therefor along the lines of its wires, cables or other conduits, with television and radio service. The Chairman and Board of Trustees shall have power to prescribe reasonable quality standards for such service and shall regulate rate increases so as to provide reasonable or compensatory rates for such service including installation charges. The procedure provided in Section 18-2206, R.R.S., 1943, now in force and effect or as amended shall be used in establishing reasonable and compensatory rents or rates for the services including installation charges.


Section 3. The Village of Ansley may, by appropriate ordinance, levy an annual occupation tax against Newcabe of Ravenna.

Section 4. In the event of violation of any franchise provision granted by the Village of Ansley, Nebraska to Newcabe of Ravenna or the provisions of Sections 18-2201 to 18-2205, R.R.S., 1943, now in force and effect or as amended, the Village of Ansley shall immediately serve notice of such violation upon the said Newcabe of Ravenna with directions to correct such violation within ninety days or show cause why such violation should not be corrected at a public hearing held in conjunction with the next regularly scheduled meeting of the Chairman and Board of Trustees of the Village of Ansley, Nebraska. Continued violation may be enjoined by the district court. Any person who willfully violates these provisions or of any franchise ordinance of the Village of Ansley, Nebraska shall be guilty of a misdemeanor and shall, upon conviction thereof, be punished by a fine of not more than five hundred dollars.

Section 5. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

Section 6. This ordinance shall be in full force and take effect from and after its passage, approval and publication as required by law.
