## VILLAGE OF ANSLEY Regular Meeting March 11, 2024 – 6:30 p.m.

A regular meeting of the Chairperson and Board of Trustees of the Village of Ansley, Nebraska, was held in the Municipal Auditorium on Monday, March 11, 2024, at 6:30 p.m. Present were Chairperson Mills, Trustees Rehfeld, Hogg, Henry and Fecht. Also present was Michelle, Dallas, Lanette Doane, Andy and Cassandra Gibbons and Melissa Schulte.

Notice of this meeting was by posting in three (3) public places, the Clerk's Office, Flatwater Bank and the Ansley Post Office as required by law. Notice was also posted on the Village website. Availability of the agenda was communicated in advance thereof to the Chairperson and Board of Trustees of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairperson Mills opened the meeting at 6:31 p.m.; the Pledge of Allegiance was recited; compliance with the open meeting act was verified. No comments during the public comment period.

Trustee Hogg moved to waive the reading and approve the February minutes as presented and Trustee Rehfeld seconded the motion. On roll call vote the following Trustees voted AYE: Hogg, Rehfeld, Mills, Fecht, Henry; NAY: None; motion carried.

Lanette Doane spoke to the board regarding a proposal that Custer Economic Development Corporation presented to some citizens of Ansley. They have some Rural Workforce Housing money and are applying for more grant money and would like to put a single family house in Ansley. Discussion regarding what the CEDC is looking for and what is possibly needed. The board said that when that time comes, they would consider options of what the City would and/or could contribute.

Andy Gibbons gave an update of where things are at regarding the Muddy Creek Festival. The festival will be held June 28-30, 2024. They will be having a beer garden that will be on Main Street, exact location to be determined, and a live band on Saturday night. Kids games, parade, fishing tournament, and much more. They will be hiring someone to do the beer garden that will get the Special Designated License and present to the board for approval by the May meeting.

Department Head and Chairperson Reports – Dallas reported (1) still waiting to get unit 2 generator repaired since it had a troublesome fuel pump. (2) we are scheduled to do an emissions test on that unit on April 9<sup>th</sup>. There was also discussion on hiring or having a deputy or city cop that is shared with other communities. There was significant discussion on the logistics of how it would work. Chairperson Mills recommended getting a committee put together that also included concerned citizens of Ansley. No action was taken.

Michelle reported (1) she will be at clerk's school all next week, March 17-22; (2) still waiting on funds from the block grant to be released until we can open the other checking account; (3) she will be gone March 27<sup>th</sup> for their bull sale; (4) Filing deadline for Incumbents is July 15 and Non-incumbents is August 1.

Chairperson Mills reported there were many good sessions at League Conference; she took a lot of notes and there were several sessions that focused on fraud and social media.

Trustee Henry brought up the merry-go-round at Square Pegs Park and the fact that he needs to meet with R & R Welding to discuss the options to fix it. Dallas reported that Todd has already taken that out to R & R Welding. Trustee Henry will reach out to R & R Welding to discuss the options.

The board was presented with a proposal from Viking Industrial to clean and inspect the pressure tank, Well #5, and the Reservoir. Dallas mentioned that this is a mandatory inspection/cleaning that has to be done every five years and that it is needed. Trustee Henry moved to approve the \$4,000 proposal from Viking Industrial for the pressure tank cleaning and inspection and the cleaning and inspection of the reservoir and Trustee Rehfeld seconded the motion. On roll call vote the following Trustees voted AYE: Henry, Rehfeld, Fecht, Hogg, Mills; NAY: None; motion carried.
