ANNUAL ORGANIZATION OF THE BOARD OF TRUSTEES
OF THE VILLAGE OF ANSLEY

The members of the Village Board of Trustees were called together at 7:02 p.m. and all members present were duly elected and appointed and qualified members of the Board of Trustees of the Village of Ansley, Nebraska. Those present were Scott Rehfeld, Rob Henry, Chris Hogg, Crystal Murrish, and Joel Schulte. Compliance with the open meeting act was verified.

Election of the Chairperson and Chair pro-tem was now in order. Trustee Henry nominated Rehfeld for Chairperson. Trustee Henry moved to close nominations and Trustee Hogg seconded the motion. On roll call vote the following Trustees voted AYE: Henry, Hogg, Murrish, Schulte, Rehfeld. Motion carried. Rehfeld elected to serve as Chairperson through the regular meeting in December 2026. Trustee Rehfeld nominated Chris Hogg for Chair pro-tem. Trustee Henry moved to cease nominations and Trustee Schulte seconded the motion. On roll call vote the following voted AYE: Rehfeld, Henry, Murrish, Schulte, Hogg. Motion carried. Hogg will serve as Chair pro-tem through the regular meeting in December 2026.

Chairperson Rehfeld made the following appointments in consultation with the Board and asked they be confirmed by the Board.



Trustee Hogg seconded the motion and on roll call the following Trustees voted AYE: Rehfeld, Hogg, Murrish, Schulte, Henry. Motion carried. Chairperson Rehfeld agreed to serve as Ansley's representative to the Loup Basin RC&D Council and Travis Harrop agreed to continue to serve as Ansley's representative to the LASWA Board.

There being no further business to come before the Board, Chairperson Rehfeld adjourned the meeting at 7:13 p.m.
